- Rights of Broadcasting Organizations: Protection for rebroadcasting and public communication of broadcasts (valid for 25 years).
- **Patents:** Exclusive rights for inventions, valid for 20 years.
- Industrial Design: Protection for the ornamental/aesthetic aspects of products.
- Trademarks: Distinctive signs identifying goods or services of a specific origin.
- Geographical Indications: Identifiers for goods based on geographical origin, quality, or reputation.
- Layout Design: Protection for semiconductor IC layouts.
- **Trade Secrets:** Confidential information like formulas, processes, and strategies that provide a competitive advantage.

#### 3. Protection of Plant Varieties and Farmers' Rights

- Overview of the Protection of Plant Variety and Farmers' Rights Act, 2001.
- Importance of safeguarding the rights of farmers and plant breeders to promote agricultural innovation.
